

**AN ORDINANCE AMENDING THE TOWN OF ORDWAY
PERSONNEL POLICY 2.48.050 HOLIDAY**

WHEREAS, the Board of Trustees of the Town of Ordway determines and finds that it is the best interest of the Town to reduce the number of recognized holidays

WHEREAS, the Board of Trustees have reviewed the current
paid holiday's observed by staff

WHEREAS, the Board of Trustees have concluded that changing the current holiday schedule that is currently in place in the Town by Ordinance 2.48, Holidays 2.48.50 would be in the best interests of the town and public

WHEREAS, the Board of Trustees has authority pursuant to C.R.S. Section 12-43.4-301 to enact and amend local ordinances.

NOW, THEREFORE, BE IT ORDANINED BY THE BOARD OF TRUSTEES OF THE TOWN OF ORDWAY, COLORADO AS FOLLOWS.

1. The Ordway Municipal Code of Ordway, Colorado, O.M.C. 2.48.50 is hereby amended, as set forth below:

The following holidays will be granted to all permanent or temporary town employees: the first day of January, commonly called *New Year's Day*; the third Monday of January, commonly called *Martin Luther King Jr. Day*; the third Monday in February, commonly called *Presidents Day*; the last Monday in May, commonly called *Memorial Day*; the 4th day of July, commonly called *Independence Day*; the first Monday in September, commonly called *Labor Day*; the second Monday in October, commonly called *Columbus Day* the 11th day of November, commonly called *Veterans Day*; the fourth Thursday in November, commonly called *Thanksgiving Day*; the *day following Thanksgiving Day*; The 24th day of December, known as *Christmas Eve*; the 25th day of December, commonly called *Christmas Day*. In case any of said holidays falls upon a Saturday then the Friday immediately preceding shall be considered as the holiday. In case any of said holidays falls upon a Sunday, then the Monday immediately following shall be considered as the holiday.


Resolution 2020-12 To Establish the Mill Levy for 2021

A Resolution entitled "A Resolution for the Mill Levy on each dollar worth of property as per the assessed value thereof as shown by the Assessor of Crowley County for the fiscal year of 2021 as fixed by the Board of Equalization."

Be it ordained by the Board of Trustees of the Town of Ordway, Colorado:

Section 1: That there be and is hereby levied upon each dollar worth of property within the corporate limits of the Town of Ordway for the purpose of defraying the necessary expenses and paying all expenses of the said Town for the fiscal year beginning January 1, 2021 for a total of 26.698 mills on each dollar worth of property as per assessed value thereon as shown by the return of the Assessor of Crowley County for 2020, fixed by the Board of Equalization.

Surgeries completed in 6 rural Colorado Towns Since June 2019!

To Whom It May Concern,

Bergen Spay & Neuter Alliance is expressing our interest in utilizing the old townhall/firehall building on Main St. in Ordway, CO on January 20-24, 2021 for a spay and neuter clinic to help support families and pets in Ordway and surrounding areas. This clinic will be available for both residents and employees of the town. We plan on scheduling up to 180 dogs and 100 cats over the four days of the clinic. We offer high volume, high quality spay and neuter services completed by our lead vet Dr. Ruth Parkin (CO Lic. #8865), in our state of the art surgical unit "Wendel".

Thanks to the generosity of Mile High Canine Rescue, DOG spaces will be offered at a discounted rate of \$30 (usually \$130) with financial sponsorships available to cover up to 100% of the cost! That's right, people in your community could get their pets fixed, vaccinated and microchipped for FREE! Dog spaces will include a Rabies, DHLPP vaccine and a microchip if needed! CAT spaces are currently being provided at our discounted rate of \$55 with FVRCP, Rabies, Microchip being \$15 each. We are continuing to work on additional funding to hopefully help offset our discounted price for cats, but we may not know until closer to the clinic date if we are able to reduce that fee. We will also gladly accept feral/community cats in our available spaces.

While we are a 501c3 non-profit organization, it is still extremely expensive for us to conduct these clinics and unfortunately we are not given the same discounts extended to other shelters and rescues. As such, rural areas are often willing to help host our clinics at locations in their communities by providing the facility for us to use during our clinics. This helps local residents get the discounted veterinary services they need, and makes a lasting impact on the community...hopefully it also helps AC keep residents safe by keeping roaming prone animals at/get home too!

Please let us know if the Ordway community is able to assist us with our clinic needs. We are always delighted to be able to give credit where credit is due, not only on social media, but also through fliers or other advertisements provided to our participants that may help your community obtain additional rentals/services. Facility Requirements: Access to the facility about noon the day before the clinic to set-up and get the surgical unit parked and ready, daily access to the building starting at 6:30am until finished (usually about 5-6pm, but has been as late as 8 or 9!). Enclosed area large enough to hold approx. 60 large dog kennels, heat/air, water and electricity (we bring our own tables/chairs, autoclave and sanitation equipment, office supplies, kennels, etc.). parking for our RV style surgical unit close to entrance door (if not available inside, on street/parking area). We ALWAYS strive to leave the space ready for its next inhabitants by making sure its cleaner than it was when we got it!

BONUS FACILITY AMENITIES (you never know unless you ask, right?): Wifi/Internet (this is how we communicate with the surgical team), a place for our surgical unit (professionally converted Class C style RV unit) to park inside the venue, laundry facilities.

COVID-19:
Due to the continuing COVID pandemic, we have implemented even more stringent cleaning, sanitation and other restrictions in order to keep participants as safe as possible. We also limit the number of volunteers/staff, ask for all pet owners to remain in their vehicles with their pets until we specifically let them know we are ready for them, limit access to the building to one participant at a time while dropping off/picking up pets, stagger drop off / pick up times, provide "paperless" sign-up and go-home paperwork, etc. We also ask for use of masks and adherence of the 6' social distance spacing.

**AN ORDINANCE AMENDING THE TOWN OF ORDWAY
RETAIL MARIJUANA CODE**

WHEREAS, the Board of Trustees of the Town of Ordway determines and finds that it is the best interests of the Town to recognize certain revenue from marijuana related sources; and

WHEREAS, the Board of Trustees of the Town of Ordway have reviewed the application fee for implementation of retail marijuana establishments previously given licenses in the Town and found that their existence and operation; and

WHEREAS, upon review, it has been determined that a prior Board of Trustees passed conflicting provisions of Ordinance 546 on the subject of application fees and renewal fees; and

WHEREAS, the Board of Trustees have concluded that clarifying the ambiguity on fee on licenses that are currently in place in the Town by Ordinance 546 would be in the best interests of the Town and the public; and

WHEREAS, the Board of Trustees has authority pursuant to C.R.S. Section 12-43.4-301 to enact and amend local licensure requirements of retail marijuana;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF ORDWAY, COLORADO AS FOLLOWS:

SECTION 1: Section 5.28.090 of the Ordway Municipal Code is repealed in its entirety.

SECTION 2: A new Section 5.28.090 of the Ordway Municipal Code is enacted as follows:

Section 5.28.090 Application Fees and Renewal Fees: For applications filed in 2018 and thereafter, the initial application fee is \$5,000.00 said fee is non-refundable. The renewal application fee shall be \$2,500.00 per year on succeeding years thereafter which will be due on the anniversary date of the license.
